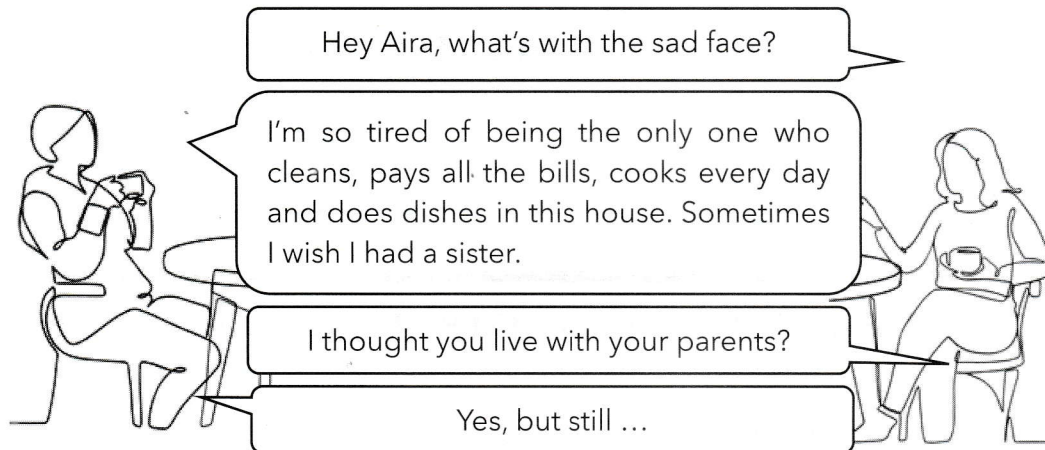

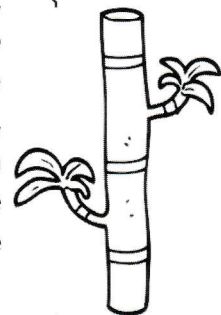

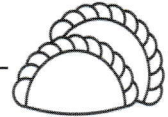

Another amazing feature of bamboo is that it is the only type of grass that can develop itself into a forest. Even after harvesting, new shoots will continue to sprout from its extensive root system without having to replant. Because of all these unique characteristics, bamboo is rightfully labelled as a highly renewable and sustainable resource.

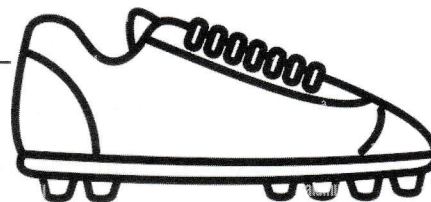


